Dr. Ambedkar Foundation an autonomous body was set up on 1992 under the Ministry of Social Justice and Empowerment, Govt. of India. Hon'ble Minster, Social Justice and Empowerment is the Chairperson of the Foundation.

2. The main objectives of the Foundation inter alia include implementation of programmes and activities for furthering the ideology and message of Baba Saheb Dr. B.R.Ambedkar among the masses in India as well as abroad. The Foundation has been entrusted with the responsibility of managing, administering and carrying on the schemes and programmes, details are as under for SCs & STs.

#### (i) Dr. Ambedkar Medical Aid Scheme

The scheme is meant to provide financial assistance to Scheduled Castes and Scheduled Tribes patients, suffering from serious ailments, for surgery related to kidney, heart, cancer and brain, spinal surgery or any other life threatening disease.(details may pl. see Annexure-A).

(ii) Dr. Ambedkar National Relief to SC/ST Victims of Atrocities

The scheme is in the nature of contingency arrangement to provide instant monetary relief to the victims of relatively heinous offences of atrocities under the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989. The relief amount under this Scheme would be directly provided to the victims or their family members or dependents by the Foundation (details may pl. see Annexure-B).

(iii) Dr. Ambedkar Scheme for Social Integration through Inter Caste Marriages

The objective of the scheme is to appreciate the socially bold step, of an Inter-caste marriage, taken by the newly married couple and to extend financial incentive to the couple to enable them to settle down in the initial phase of their married life (details

may pl. see Annexure-C).

3. The above welfare schemes for SCs & STs for their life saving, justice and values of liberty, equality, fraternity etc in the society. However, it is requested to kindly spread the masses through hospitals, library etc. among the above scheme in your States.

### Dr. Ambedkar Medical Aid Scheme

(Revised on 15.01.2018)

The objectives of "Dr. Ambedkar Medical Aid Scheme" is to extend medical aid grants to the patients belongs to the Scheduled Castes and Scheduled Tribes suffering from serious ailments requiring surgery of Kidney, Heart, Liver, Cancer and Brain or any other life threatening diseases including organ transplant and spinal surgery, whose annual family income is not more than Rs.3,00,000/- (Rupees Three Lakhs). The Scheme will be implemented through the following Hospitals:

- (i) All India Institute of Medical Sciences (AIIMS), New Delhi and AIIMS in other States.
- (ii) Sanjay Gandhi Post Graduate Institute, Lucknow, Uttar Pradesh.
- (iii) Patna Medical College Hospital, Patna, Bihar.
- (iv) Jabalpur Hospital and Research Centre, Jabalpur, Madhya Pradesh.
- (v) B. Barua Cancer Institute, Guwahati, Assam.
- (vi) Birla Heart Foundation, Kolkata, West Bengal.
- (vii) Kalinga Hospital Ltd. Chandrashekharpur, Bhubaneswar, Orissa.
- (viii) Tata Cancer Research Institute, Mumbai, Maharashtra.
- (ix) Nizam Institute of Medical Sciences, Hyderabad, Andhra Pradesh.
- (x) The Voluntary Health Services, Chennai.
- (xi) All CGHS approved Hospitals as revised from time to time by the Ministry of Health & Family Welfare, Government of India.
- (xii) All State Government Medical Colleges attached Hospitals even if not included under CGHS Scheme.
- (xiii) All State Hospitals.
- (xiv) All Hospitals recognized by State Government
- (xv) All Hospitals fully funded by either the Central Government or the State Governments.
- (xvi) All Government Hospitals in District Headquarters/ major towns where surgery or treatment facility for Kidney, Heart, Liver, Cancer and Brain or any other life threatening disease including organ transplant and spinal surgery is available.
- (xvii) Any other hospital, which the Chairman of the Foundation is convinced that the relevant case is justified under facts and exceptional circumstances.
- 2. **ELIGIBILITY**
- (i) The applicant shall belong to Scheduled Caste and Scheduled Tribe Community.

- (ii) Annual family income shall not exceed Rs. 3,00,000/- (Rupees Three Lakhs).
- (iii) The Scheme covers major ailments which need surgery such as kidney, heart, liver, cancer, brain or any other life threatening disease including organ transplant and spinal surgery.

#### 3. HOW TO APPLY

- The applicant shall apply for medical aid in the prescribed application form or on plain paper as per details in the prescribed proforma available in DAF website. The application format is attached as Annexure-1. The application must be submitted along with the self-certified copies of (i) the caste certificate, (ii) income certificate, (iii) ration card/ aadhaar card and (iv) estimated cost of the surgery duly certified by the Medical Superintendent of the Hospital (as at Annexure-11).
- The duly filled in form should reach the Director, Dr. Ambedkar Foundation, 15, Janpath, New Delhi, at least 15 days before the date of surgery.

#### 4. **DISBURSEMENT**

4.1 100% of the estimated cost of the surgery will be directly released to the concerned Hospital, with a maximum ceiling limit as indicated in the following table in each case, in the form of through RTGS/NEFT / DD:

Heart Surgery -	Rs. 1.25 lakh
Kidney Surgery/ Dialysis -	Rs. 3.5 lakh
Cancer Surgery / Chemotherapy / Radiotherapy -	Rs. 1.75 lakh
Brain Surgery -	Rs. 1.5 lakh
Kidney / Organ Transplant -	Rs. 3.5 lakh
Spinal Surgery -	Rs. 1.00 lakh
Other life threatening diseases -	Rs. 1.00 lakh

- 4.2 The medical aid may be released in one instalment, before surgery, on the condition that Utilization Certificate (Annexure-IV) shall be submitted to Dr. Ambedkar Foundation by the Hospital along with final bills on the date of discharge of the patient.
- 4.3 The medical aid released to the Hospital should be utilized within a period of one month of its release. The un-utilized aid/ balance amount, if any, shall be returned to the Foundation at the earliest, in any case not later than one month after the date of discharge of the patient.
- 4.4 Medical aid from the Foundation and other sources should not exceed the total estimated cost of the surgery.
- 4.5 The Estimated Cost certificate to be submitted along with the application should contain the date fixed for the surgical operation.

#### **Documents Required**

- 4.6 The Application Form (Annexure-I attached) or on Plain Paper with the details as per the format and photograph should be accompanied with the following documents / certificates:-
  - (i) Original Estimated Cost certificate duly signed by the Medical Superintendent of the concerned hospital. It should contain the date fixed for the surgical operation.
  - (ii) <u>Self attested</u> photocopies of the following:
    - (a) Latest Income Certificate,
    - (b) Caste Certificate and
    - (c) the Ration Card/Aadhaar Card of the patient.
  - (iii) Documents required for Kidney transplant i.e. Relationship with beneficiary (Form 14, format for the decision of the Authorization Committee Certificate), Details of Donor of Kidney i.e. Name, Age, Address, Blood Group, UIDAI No. / Aadhaar No. of beneficiary.
  - (iv) For fast processing transfer of aid / grant amount in the approved cases, the bank details of the hospital (a) Account No. of the hospital (b) Name of the Account Holder (c) IFSC code may be given/provided with the application.

#### Other Conditions:

- 4.7 Medical aid from the Foundation and other sources should not exceed the total estimated cost of the surgery. A certificate in this regard should be obtained from the Medical Superintendent of the concerned Hospital.
- 4.8 The <u>Estimated Cost Certificate</u> (Annexure-II attached), accompanied with the application (Annexure-I attached), should contain the date fixed for the surgical operation.
- 4.9 Ordinarily, the cases of <u>reimbursement</u> of the expenditure incurred on the surgery / treatment in medical aid are <u>not entertained</u>. However, reimbursement may be considered on merit, if the application was received by DAF at least 15 days before the date of surgery.
- 4.10 A self attested photograph of the patient should also be affixed on the Application.

# DR. AMBEDKAR NATIONAL RELIEF TO THE SCHEDULED CASTES /SCHEDULED TRIBES VICTIMS OF ATROCITIES SCHEME

#### Revised Scheme (Year – 2020)

### I. <u>INTRODUCTION:</u>

Babasaheb Dr. B. R. Ambedkar was a great national leader of twentieth century. He was an intellectual, scholar, statesman and contributed greatly in the nation building. He led a number of movements to emancipate the downtrodden masses and to secure human rights to millions of depressed classes. He has left an indelible imprint through his immense contribution in framing the Constitution of India. He stands as a symbol of struggle for achieving Social Justice.

- 2. The main objectives of the Dr. Ambedkar Foundation, inter-alia, include implementation of programmes and activities for furthering the ideology and message of Babasaheb Dr. B. R. Ambedkar among the masses in India as well as abroad. The Foundation has been entrusted with the responsibility of managing, administering and carrying on the important and long term schemes and programmes identified during the Centenary Celebrations of Bharat Ratna Dr. B. R. Ambedkar. Dr. Ambedkar was extremely concerned with the plight of the Scheduled Castes (SCs) / Scheduled Tribes (STs) and the untouchability practiced and atrocities committed against them. He advocated for their social, economic and political empowerment.
- The incidents of atrocities still continue to be committed against the members of scheduled 3. castes despite the enactment of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 (POA Act) which seeks to prevent the commission of offences of atrocities against the members of the Scheduled Castes and the Scheduled Tribes, to provide for Special Courts for the trial of such offences and for the relief and rehabilitation of the victims of such offences and for matters connected therewith or incidental thereto. At present under the Centrally Sponsored Scheme for implementation of the Protection of Civil Rights Act, 1955 and the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989 (POA Act), 50% of the total expenditure over and above the committed liability is provided to the State Governments by way of central assistance and the Union Territories get 100% central assistance. The central assistance is mainly provided to support measures undertaken by them for effective implementation of the Acts which include providing relief and rehabilitation to the victims/dependents of atrocities, etc. as prescribed under the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Rules, 1995 (POA Rules). However, the relief is available to the victims through the State Governments/UT Administrations.

4. The Ministry of Social Justice & Empowerment cannot provide relief and rehabilitation to the victims direct even in respect of heinous crimes committed against SCs like, arson, rape, murder, etc. and hence in that respect Central Government feels slightly handicapped. Therefore, a need has been felt to provide instant monetary relief to the victims of relatively serious offences of atrocities under the POA Act in the nature of contingency arrangement and that the relief amount be directly provided to the victims by the Central Government through the Foundation. Therefore, a suitable Scheme for financial assistance to the SC victims of atrocities by the Foundation would be a befitting tribute to this illustrious Son of India.

#### II. THE SCHEME:

- 5. The Scheme would be known as 'Dr. Ambedkar National Relief to the SC/ST Victims of Atrocities Scheme'. This Scheme would be in the nature of contingency arrangement to provide instant monetary relief to the victims of heinous offences of atrocities under the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989.
- 6. The State / UT Government or the District Administration may, in the cases falling under the categories of atrocities identified under the scheme, prepare proposal for financial assistance to the SC/ ST Victim(s) of Atrocities, in the Prescribed Format (Annexure–II), and forwarded to the Foundation for its consideration. The Foundation may also take suo-motto cognizance of any case of atrocity and depute an officer(s) for visiting the place of atrocity for taking necessary action under the scheme.
- 7. The relief amount up to Rs. 5.00 lakh would be paid to each victim, with the approval of the Chairperson of the Foundation. The amount of relief will be in addition to the relief grant/ amount being given by the respective State Governments. This Scheme is meant for providing financial assistance to SC victims of atrocities or their family members or dependents in order to compensate them financially. This Scheme is formulated keeping in view the growing atrocities against the Scheduled Castes and with a view to financially assist SC / ST victims of atrocities.

#### III. ELIGIBILITY:

- 8. The eligibility criteria is as under:
  - (i) The victim should belong to Scheduled Caste / Scheduled Tribes.
  - (ii) The victim should be a Scheduled Caste / Scheduled Tribe who has suffered atrocities committed by other communities on the grounds of his/ her caste, community or identity in the society.
  - (iii) The atrocity should be of heinous type under the POA Act, 1989 like murder, rape, arson, etc.

# IV. <u>EXTENT OF ASSISTANCE</u>:

9. The assistance shall be up to a maximum limit of Rs. 5.00 lakhs. The scale of relief amounts is given at Annexure - I.

# V. NORMS FOR RELEASE OF ASSISTANCE:

- 10. The norms for release of the relief amount under the Scheme is as follows:
  - (i) The assistance shall be released to the victim or his/ her family members or legal heir solely under the discretion of the chairperson of the Foundation. The financial assistance given will be directly transferred to the Aadhar linked bank account of the Victim or his/her legal heir.
  - (ii) In the case of the crime of rape, submission of 'medical certificate' issued by an authorized medical officer of the concerned State Government is a pre-requisite for sanction of relief.
  - (iii) In the case of atrocities resulting in disabilities, the same should be certified by the competent authority indicating the percentage of disability.

#### VI. HOW TO APPLY

- 11. A proposal for financial assistance for the Scheduled Caste/ Scheduled Tribes victim of atrocities may be forwarded by the State / UT Government or District Magistrate or Collector in the Prescribed Format (Annexure II) to the Director, Dr. Ambedkar Foundation, 25 K. G. Marg, Jeevan Prakash Building, 9<sup>th</sup> Floor, New Delhi 110001, along with the copy of the FIR, Inquiry Report, Postmortem Report, Medical or Disability Certificate etc. (as the case may be).
- 12. All such proposals will be processed in the Dr. Ambedkar Foundation. It shall be the discretion of the Chairperson of Dr. Ambedkar Foundation to sanction the financial assistance to the victim(s):

Provided that the Chairperson of Dr. Ambedkar Foundation may relax the norms of the Scheme in deserving cases.

# Dr. Ambedkar Scheme for Social Integration through Inter-Caste Marriages

## (I) <u>Background</u>

- 1. Sociologists have argued that caste system is a hierarchical system in which castes are placed one above the other on the basis of social status and prestige. Dr. B. R. Ambedkar defined Indian caste system as a system based on graded inequality. It divides men into separate communities and one of its main feature, the practice of endogamy i.e. the social rule that requires an individual to marry within a specific culturally defined social group of which he/she is member, reinforces and sustains this separateness and it is this segregation, which has created difficulty in achieving Constitutional values of liberty, equality, fraternity etc in the society.
- 2. Traditionally, marriage in Hindu society was a sacrament but after the passage of Hindu Marriage Act 1955 it can be treated as a contract. However, still marriages primarily take place on the traditional grounds of Jatis (caste) and *up-jati* (sub-caste). That means marriage is inextricably linked to *Jati Vyavastha* (caste system) with its roots in the religion.
- 3. Inter-caste marriages can be one of the significant steps to reduce the caste-prejudices, abolish 'untouchability' and spread the values of liberty, equality, fraternity etc in the society.
- 4. Under the Centrally Sponsored Scheme for implementation of the Protection of Civil Rights Act (PCR) and Prevention of Atrocities (POA) Act, Central assistance to State Governments and Union Territory Administrations is provided towards incentive for inter-caste marriages where one of the spouses belongs to Scheduled Caste.
- 5. The object no. XXXI in the Memorandum of Association of Dr. Ambedkar Foundation also mandates "To organize special campaigns for removal of untouchability and caste-based prejudices and for bringing in attitudinal change in the society through communal harmony and brotherhood and receive Govt. assistance for such purposes." Given the enormity of the social challenge that an inter-caste marriage faces, the Foundation also joins the initiative for bringing in an attitudinal change among the members of society through inter-caste marriages which has the potential to bring sustainable social integration, harmony and fraternity.
- 6. Since the problem is societal, the solution has to be determined at the level of society. Further, as the matter pertains to the realm of tradition and mind-set, it has to be pursued in a calibrated manner by gradually convincing the society about the desirability of creating a progressive society for which the inter-caste marriages should be accepted as a norm. Therefore, there appears to be a need for greater involvement of Representatives of People from Panchayat to Parliament, Social Activists/ Reformers, Administration, Media etc. in the implementation of this Scheme.

# (II) The Scheme:

- 1. The Scheme would be known as 'Dr. Ambedkar Scheme for Social Integration through Inter-Caste Marriages'.
- 2. The objective of the scheme is to appreciate the socially bold step, of an Inter-caste marriage, taken by the newly married couple and to extend financial incentive to the couple to enable them to settle down in the initial phase of their married life. It is clarified that it should not be construed as a supplementary scheme to an employment generation or poverty alleviation scheme.
- 3. It shall be the discretion of the Minister of Social Justice & Empowerment & Chairman of Dr. Ambedkar Foundation to sanction the incentive to the Couple.
- 4. Submission of false/ fabricated information to the competent authority would be punishable as per law in force.

#### (III) Eligibility:

The eligibility criteria are as under:

- 1. An Inter-caste marriage, for the purpose of this Scheme means a marriage in which one of the spouses belongs to Scheduled Caste and the other belongs to a Non-Scheduled Caste.
- 2. The marriage should be valid as per the law and\_duly registered under the Hindu Marriage Act, 1955. An affidavit of their being legally married and in matrimonial alliance would be submitted by the couple.
- 3. In cases, where marriage is registered other than Hindu Marriage Act 1955, the couple is required to furnish a separate certificate as per Annexure-1 of the Format.
- 4. No incentive is available on second or subsequent marriage.
- 5. Proposal would be treated as valid if submitted within one year of marriage.
- 6. If the couple has already received any incentive from the State Govt. / UT Administration for this purpose, the amount approved / released to the couple will be adjusted from the total incentive that could be released to them under this Scheme.

# (IV) Extent of Incentive

- 1. The incentive for a legal inter-caste marriage shall be Rs.2.50 lakh per marriage. On receipt of a Pre-Stamped Receipt on a Ten Rupee Non-Judicial Stamp Paper an amount of Rs.1.50 lakh will be released to the eligible couple through RTGS / NEFT to the joint account of the couple and the remaining amount will be kept in a Fixed Deposit in the Foundation for a period of 3 years. This amount will be released to the couple alongwith the interest accrued thereon on 3 years of sanction of the incentive by the Foundation.
- 2. The Scheme was initially introduced on a pilot basis for a period of 2 years i.e. 2013-14 and 2014-15 and is being continued as a regular scheme since then.

- 3. The District Authorities and State Government should be persuaded to be more proactive in supporting Inter-Caste Marriage (one spouse SC category) by organizing Mass Inter-caste marriages in the Districts / States. They may publicize the same in the local media, arrange functions for the inter-caste marriage invite eminent personalities to grace the occasion etc. An amount at the rate of Rs.25,000/- per inter-caste marriage will be paid to the District Authorities / State Government for organizing the above programme.
- 4. An amount of Rs. 25,000/-, for each marriage, would be released to the District Authorities for organising a befitting programme in which the incentive would be handed over to the couple.
- (V) <u>Norms for release of Incentive</u>: The norms for release of the Incentive amount under the Scheme are as follows:-
  - 1. The proposal to seek incentive under the Scheme should be recommended by the Welfare Department of the State / UT Government / District Magistrate / District Collector/ Deputy Commissioner.
  - 2. The incentive for a legal inter-caste marriage shall be Rs.2.50 lakh per marriage. On receipt of a Pre-Stamped Receipt on a Ten Rupee Non-Judicial Stamp Paper the total amount of incentive will be released to the eligible couple in a single instalment through RTGS / NEFT to the joint account of the couple.
  - 3. Power of Relaxation: Chairperson DAF & HMSJE may relax any provisions of the scheme in deserving cases.
  - 4. How to apply: A statement showing copies of documents which are to be submitted by the applicant as per the enclosed Format.

The proposal under the Scheme is required to be forwarded with recommendation from the concerned District Magistrate, District Collector / Deputy Commissioner / Social Welfare Department of the concerned State Government / UT to the Director, Dr. Ambedkar Foundation, Jeevan Prakash Building, 9th Floor, 25, K.G.
